## DISTRIBUTOR AGREEMENT

Agreement between the named Applicant (hereinafter "APPLICANT") and Asia Herbal Biotech Sdn. Bhd. (hereinafter "AHB") effective under the terms and conditions below:

1. APPLICANT hereby applies for authorisation as a Distributor in AHB's Network Marketing Programme. For a period of 21 days from the mailing of this Application, or until such time as AHB notifies APPLICANT of this Application's acceptance or rejection, APPLICANT is provisionally authorised as a Distributor and granted the rights to sell AHB products. AHB reserves the right to accept or reject any application for any reason, in accordance with the terms and conditions set forth in the AHB Policies and Procedures, as such now exists or may hereafter be amended.
2. Upon acceptance as a Distributor by AHB, APPLICANT is authorised as a Distributor for one calendar year. AHB will automatically renew Distributor authorisation annually by debiting the Distributor's account on file in the amount of RM38, unless the Distributor notifies AHB in writing prior to the anniversary date that he/she desires to cancel the Distributorship.
3. APPLICANT has read and agrees to be bound by the terms of this Agreement, the AHB Cellular Marketing Plan and the Policies and Procedures, all of which are incorporated herein by reference and made a part hereof for all purposes. AHB reserves the right to change the Marketing Plan and the Policies in its sole discretion, and APPLICANT agrees to be bound by such charges.
4. APPLICANT is an independent contractor under the terms of this Agreement, and not an agent, employee or legal representative of his/her sponsor or AHB, and will in no way represent him/herself as such. As such, APPLICANT has no power to bind AHB to any obligation and APPLICANT is responsible for all applicable income, license or fee arising out of APPLICANT's activities hereunder.
5. APPLICANT will not produce, promote, or use materials of any kind describing AHB's names, programmes, products, and trademarked, copyrighted or otherwise protected materials except as permitted in AHB's policies.
6. APPLICANT has the duty to supervise and train any Distributors that he/she may sponsor as described in the Policies, APPLICANT will explain AHB's programmes honestly and completely when presenting them to others. APPLICANT understands and will make clear in any presentation the following: that no earnings are guaranteed by AHB or its programmes; no Distributor will earn money solely for sponsoring; no specific amount of product must be purchased at any level; commissions are based on product sales; that there are no exclusive territories for Distributors in the programme.
7. APPLICANT agrees that compensation is only paid for sales of product to customers and end users as defined in the Policies and in the Company's Marketing Plan.
8. Any sale or assignment of this Agreement or Distributor authorisation must be approved of in writing by AHB. Successors in interest or assigns must comply with all programme requirements.
9. The undersigned hereby acknowledges that he/she is of legal age and authorised to bind APPLICANT to each of the terms set forth herein and to the terms of the Policies and Procedures.
10. This Agreement is subject to a cooling-off period of 10 working days commencing on the date of this Agreement, within which the APPLICANT shall have the right to rescind this Agreement by serving written notice to AHB. Should this Agreement be rescinded within the cooling-off period, AHB shall refund all payments made under this Agreement to the APPLICANT, if any. Save where the APPLICANT has requested for delivery in respect of a product order before the expiry of the cooling-off period, the APPLICANT would be deemed to have waived his/her right to rescind this Agreement. Notwithstanding the right of the APPLICANT to terminate this Agreement during the cooling-off period. A Distributor may cancel his/her Distributorship at any time and for any reason upon notice to the Company. If a Distributor elects to cancel his/her Distributorship, AHB will refund the price of his/her product order(s) and/or Starter Kit in accordance with its policies.
12. AHB reserves the right to cancel any Distributorship for cause as such defined in the Policies.
13. No purchase or investment is necessary to become an Independent Distributor other than the purchase of a Starter Kit, which is sold at company cost. Purchasing the Starter Kit is mandatory.

## TERMS AND CONDITIONS

You are an independent contractor and not an employee of AHB.

You may not sell, assign or transfer your Distributorship to any person or entity without AHB's express written permission.

You must pay an annual renewal fee of RM38 to renew your Distributorship, which entitles you to continued Distributor benefits. You may arrange for payment of the annual renewal fee through automatic withdrawal from your checking account, by credit card, or cash.

You must pay all required taxes on any income you earn as an Independent Distributor, unless you qualify with your taxing authority for income tax exempt status.

In order for you to qualify for commissions, you must (1) sell to customers or end users a minimum of 70% of your product orders; and (2) provide your retail customers with an official AHB retail receipt which specifies date of sale, amount of sale, item(s) purchased, and the AHB Satisfaction Guarantee. You must retain all sales receipts for two years.

Specific AHB product names as well as the corporate name and logo are the exclusive property of AHB. You may not use AHB's product names, the corporate name or logo to promote your independent business.

You are free to participate in other multilevel marketing ventures, but you may not sell or promote to other AHB Distributors similar or competitive products or services or any other multilevel marketing opportunity.

AHB Downline Genealogy Reports are confidential and proprietary business trade secrets. You may not use the reports for any purpose other than to develop your AHB business. Specifically, you must not disclose any information contained in the reports to a third party or use the reports to compete with AHB or to recruit or solicit other Distributors to participate in other multilevel marketing ventures.

AHB's failure to exercise any rights as set forth in this Agreement or to insist on your strict compliance with the terms and conditions of this Agreement the Policies and Procedures does not constitute a waiver of AHB's right to require compliance therewith. Waiver of any term and condition of this Agreement or provision of the Policies and Procedures must be in writing and signed by an authorised officer of AHB.

AHB's waiver of any Distributor default does not affect AHB's rights with respect to any subsequent default or the rights or obligations of any other Distributor. Delays or omissions by AHB in exercising rights which might arise from a Distributor's default do not affect the Company's rights concerning the default or any subsequent default.

You have the right to cancel your Distributor Agreement at any time and for any reason. If you choose to cancel your Distributor Agreement, simply notify AHB in writing. On the cancel your Distributor Agreement / Termination of the Direct Seller's relationship with a company, Companies shall buy back any unsold but sale able product inventory, including promotional material, sales aids and kits, and credit the Direct Seller's original net cost thereof less a handling charge to the Direct Seller up to 10% of the net purchase price and less any benefit received by the Direct Seller based on the original purchase of the returned goods. Buy back will not be accepted for products damaged contents and packaging, has expired etc due to negligence by stockists, members or customers. Buy back can be done by completing the Claim Form together with the product to be returned.

AHB reserves the right to cancel any Distributorship at any time for cause if the Distributor violates the terms and conditions of this Agreement or the provisions of the Policies and Procedures and marketing Plan.

AHB reserves the right to revise or amend the Policies and Procedures and the Marketing Plan.
